

**BY-LAW NO. A-3**

**A BY-LAW TO ESTABLISH HONORARIA AND EXPENSES FOR THE MAYOR AND COUNCIL OF THE TOWN OF NACKAWIC**

BE IT ENACTED by the Council of the Town of Nackawic as follows:

**1. Title**

This by-law may be referred to and cited as the By-Law To Establish Remuneration for the Mayor and Council of the Town of Nackawic.

**2. Term**

Effective Date: January 1, 2003

**3. Honoraria**

(1) The annual salary of the Mayor, Deputy Mayor and each member of Council shall be as follows:

|    |                    |                             |
|----|--------------------|-----------------------------|
| A) | Mayor              | \$2,319.00 (\$193.25/month) |
| B) | Deputy Mayor       | \$1,764.00 (\$147.00/month) |
| C) | Councillor         | \$1,236.00 (\$103.00/month) |
| D) | Committee Meetings | \$22.50 (each)              |

(2) Commencing January 1, 2003, the honoraria for Mayor and Council shall increase annually at the same rate (percentage) as the annual increase provided in the annual municipal budget for non-unionized employees.

**4. Monthly Expenses**

A member of Council of the Town of Nackawic shall be paid a monthly expense as follows:

| A) | Mayor        | \$1,442.40 (\$120.20/month) |
| B) | Deputy Mayor | \$1,148.40 (\$95.70/month)  |
| C) | Councillors  | \$721.00 (\$60.08/month)    |

**5. Expenses**

5.01 A member of the Council of the Town of Nackawic shall be paid an allowance for expenses as follows:

- A) Per Diem \$80.00 maximum per work day lost
- B) Meals/Day A maximum of \$60 per day or any meal in the following proportions: breakfast - \$10, dinner - \$20, supper - \$30 (receipts not required)
- C) Kilometer Rate \$0.32 per kilometer

5.02 Commencing January 1, 2003, the kilometer rate for Mayor and Council shall increase at the same rate (percentage) according to the provincial kilometer rate.

**6. Penalty For Absence**

Council may, by resolution, deduct from the amounts payable under section 3 of this by-law a sum of \$15.00 per meeting for non-attendance at Council meetings without reasonable cause.

**7. Authority For By-law**

Section 36(3) of the *Municipalities Act*, R.S.N.B. 1973, C.M-22, and amendments thereto.

**8. Repeal Provision**

8.01 By-Law No. 57-03, A By-Law To Establish Honoraria and Expenses to Nackawic's Mayor and Council, passed by Town Council on January 20, 2003, and amendments thereto, is hereby repealed.

8.02 The repeal of By-Law No. 57-03, A By-Law To Establish Honoraria and Expenses to Nackawic's Mayor And Council, and amendments thereto, shall not affect any penalty, forfeiture or liability, incurred before such repeal or any proceeding for enforcing the same completed or pending at the time of repeal; nor shall it repeal, defeat, disturb, invalidate or prejudicially affect any matter or thing whatsoever completed, existing or pending at the time of repeal.
