Mayor Kitchen directed the CAO to reach out to Ginger Agency and ask if they can come up with other options for the Town's Logo for Council to view and make a decision on.

Councillor Farnsworth asked if Randy discussed security options with Chief Hopkins.

FIRE

Councillor Simpson asked about the big generator the fire department has and if they were able to use it.

Randy Wilson stated yes, it is set up and ready to go if needed.

Councillor Simpson asked if the generator will supply only the fire hall with electricity.

Randy Wilson stated no, it will supply the Town Hall as well.

Councillor Farnsworth asked if they started the Chase the Ace Fundraiser again.

Mayor Kitchen stated no, they are still in discussions.

Recreation -

Councillor Farnsworth stated the Go Boys Event will be held on March 24 with sledge hockey; curling and bowling. Hoping to have Brandon Brewer attend and speak as well.

Councillor Farnsworth stated Family Fun Day is happening on Monday, February 17 with a lot of events planned for the day. Hoping to have a snowman sculpture competition.

Councillor McConaghy stated there will be a recreation meeting at the Big Axe Brewery on Sunday, March 9 at 5:30 pm.

Councillor Farnsworth stated the Learn to Skate program is going very well, with lots of volunteers helping out. There was 34 in attendance last week.

Public Works -

Councillor Toole stated the tender for the left-hand turn lane have gone out and the closing is Friday, February 7 at 2 pm.

Randy Wilson stated several contractors have already purchased them.

Councillor Toole asked when the plough truck will be ready.

Special Reports -

PUBLIC HEALTH

Councillor Farnsworth stated the Public Health meeting went well. They learned the ABC's around cooking, they will get more information on it and get it out to the community.

Councillor Toole stated they discussed Extreme Heat conditions, and Fredericton is working on cooling stations. When they receive more information on it, Nackawic will open up a place for cooling, heating and charging.

Councillor Farnsworth stated they discussed the three main things that are killing people today: 1) lack of exercise 2) diet and 3) stress. They also discussed the Blue-Green Algae.

Councillor Toole stated he received information on the Coronavirus from EMO NB that the risk assessment is raised from 2 to 3 but the risk level in Canada is still low.

DOCTOR RECRUITMENT

Councillor Simpson reported on the Doctor Recruitment meeting and stated Dr. Hebb will be closing her practice in December 2020 and stated the town needs to recruit 1 or more doctors to replace her.
